

# 2019 ARIZONA TAX CREDIT

You can divert directly a portion of your owed state income tax dollars to benefit Crane children. A married couple filing a joint return can divert up to \$400. A single individual, a head of household or married individual filing separately can divert up to \$200 of their state income taxes to Crane schools. You can contribute these dollars to our schools for extracurricular activities and deduct that amount directly from your 2019 state income taxes. Any individual (\$200), or couple filing a joint return (\$400), may take advantage of this tax credit. Crane has an extracurricular activity fund. It is for school-sponsored activities. These are educational or recreational oriented. They supplement our school programs. The fund supports many competitive, entertainment, and experiential activities, and student organizations. The activities help students enrich classroom learning and develop qualities such as leadership, team play, and cooperation. They also provide safe, supervised activities after school and intersession activities.

**Support local schools. Sponsor extracurricular activities for Crane children.  
Give the tax dollars to a Crane school that you would otherwise pay to the State of Arizona!**
